## **Keeping Children Safe in Education 2021**



The 2021 version of Keeping Children Safe in Education was published on 6th July 2021. We shared a summary of the changes at the locality briefings and will make it available to all DSLs. We will also be producing a set of slides which you can adapt to use in your September training. Please let us know if you would like these. They will be available from Tuesday 13th September. We will also update our Child Protection and Safeguarding policy before the summer holidays.

## New duty for Virtual School Headteachers to promote the education of children with a social worker

From September 2021, the role of the Virtual School Headteacher (VSH) will be extended to promote the education of children with a social worker.

This new duty aims to use the experience and expertise of VSHs, giving them strategic leadership responsibility. VSHs are not being asked to provide support to individual children and their families.

The government's Children in Need review in 2019 found that children with a social worker do worse than their peers at every stage of their education and poor outcomes persist, even after social worker involvement ends. Experiences of adversity and trauma can create barriers to education that affect attendance, learning, behaviour and wellbeing. However, with the right support in place, children can overcome these barriers to reach their potential.

Virtual School Heads, who have statutory responsibilities for looked-after and previously looked-after children, are well positioned to enhance partnerships between agencies and raise aspirations for this cohort of children. The impact should be the closing of the attainment gap so that children can achieve their potential.

In Northumberland we have a strong starting point, with support services for school attendance, children missing education and schools' safeguarding already working together in the Virtual School. Planning is underway so that we can begin implementation of the duty from September, and professionals will receive further information in due course. The planning will focus on the training and resources needed to:

- enhance partnerships between education settings and the local authority so agencies can work together
- identify the needs of the cohort and address barriers to poor educational outcomes and ensure pupils make educational progress

- offer advice and support to key professionals to help children make progress, including through increasing their confidence in using evidence-based interventions
- promote practice that supports children's engagement in education, recognising that attending an education setting can be an important factor in helping to keep children safe from harm.

DSLs will have a role in fulfilling the duty and this is now referred to in the latest version of Keeping Children Safe in Education, page 100:

[DSLs will] help promote educational outcomes by sharing the information about the welfare, safeguarding and child protection issues that children, including children with a social worker, are experiencing, or have experienced, with teachers and school and college leadership staff. Their role could include ensuring that the school or college, and their staff, know who these children are, understand their academic progress and attainment and maintain a culture of high aspirations for this cohort; supporting teaching staff to identify the challenges that children in this group might face and the additional academic support and adjustments that they could make to best support these children. DfE research into improving educational outcomes for children with a social worker will continue, and all VSHs will contribute to this as they fulfil their new duty from September.

This new duty is explained in more detail in DfE guidance <u>Promoting the education of children with a social</u> worker (June 2021).

#### Ofsted review of sexual abuse



The Government have recently requested Ofsted to look at whether schools and colleges have appropriate processes in place to allow pupils to report sexual abuse concerns freely, knowing these will be taken seriously and dealt with swiftly and appropriately. The key recommendations from the report were:

#### Recommendations for school and college leaders

School and college leaders should create a culture where sexual harassment and online sexual abuse are not tolerated, and where they identify issues and intervene early to better protect children and young people. In order to do this, they should assume that sexual harassment and online sexual abuse are happening in their setting, even when there are no specific reports, and put in place a whole-school approach to address them. This should include:

- a carefully sequenced RSHE curriculum, based on the Department for Education's (DfE's) statutory
  guidance, that specifically includes sexual harassment and sexual violence, including online. This should
  include time for open discussion of topics that children and young people tell us they find particularly
  difficult, such as consent and the sending of 'nudes'
- high-quality training for teachers delivering RSHE
- routine record-keeping and analysis of sexual harassment and sexual violence, including online, to identify patterns and intervene early to prevent abuse
- a behavioural approach, including sanctions when appropriate, to reinforce a culture where sexual harassment and online sexual abuse are not tolerated
- working closely with LSPs in the area where the school or college is located so they are aware of the range of support available to children and young people who are victims or who perpetrate harmful sexual behaviour
- support for designated safeguarding leads (DSLs), such as protected time in timetables to engage with LSPs
- training to ensure that all staff (and governors, where relevant) are able to:
  - better understand the definitions of sexual harassment and sexual violence, including online sexual abuse
  - o identify early signs of peer-on-peer sexual abuse
  - o consistently uphold standards in their responses to sexual harassment and online sexual abuse Following the publication of the report Ofsted published an updated handbook for inspection

Northumberland Children's Services Procedures Manual

### **Multi Agency Referral Form (MARF)**

Children's Services has been reviewing all systems to ensure they are aligned with the Signs of Safety framework. Earlier this year we shared a draft referral form with you, the Multi Agency Referral Form (MARF) and all feedback from you was shared with Children's Services. Two significant actions have now taken place:

1. The new form has gone live, meaning there is now one referral form for both Early Help and Children's services. The link to the form is here:

2. In terms of Early Help the following information from Emma Walker provides an update:

"The Northumberland (Multi Agency Referral Form) MARF is now up and running, this is now also our new Early Help referral pathway (replacing the Hub referral).

I thought it would be useful to just mention some tweaks in terminology, the term Hub has been somewhat confusing as the "hubs" have grown so much over the years, we also now have the Community Hub and hub is being used in the discussion around the new Supporting Families in terms of Family Hubs.

The use of the Early Help Pathway by GPs is so important, so I wanted to email to make sure we avoid any confusion, to try and make things clearer we are changing some terminology so that:

A Hub referral - is now Early Help Support Request

Rather than referring to the Hub - you refer to **Early Help First Contact. The email address is now:** <a href="mailto:earlyhelp@northumberland.gov.uk">earlyhelp@northumberland.gov.uk</a>

If we cannot find a solution to a situation those families may be discussed at the - Early Help Virtual Hub Meeting

In practice this makes very little difference, the MARF (with Early Help Support request ticked) still comes to us and we will look to find the best support for the young people and families you refer.

At this time a copy of the MARF will not be sent back to you therefore you need to continually copy and save your entries as you are typing them in. This issue is being addressed by the company who have developed the system.

We will shortly be sharing a quick survey with you to gauge initial feedback on the MARF.

### **Early Years Framework 2021**



The <u>new framework</u>, effective on 1st September, was published recently.

The main changes are in learning and child development - the safeguarding changes this year are minor clarifications or the addition of links to guidance published since the last time the framework was updated in 2017. These include online safety, information sharing and criminal record checks.

### **Collection of information for MASH enquiries**



As you know members of the Schools' Safeguarding Team will contact DSLs when we require intelligence for MASH. The electronic system used by children's services (liquid logic/ICS) has been refreshed to ensure the information collected from all agencies follows the S-o-S model, therefore the information we will request will cover three main headings; Worries, Strengths & Safety and Safety Planning. We will be asking you

the following questions in relation to MASH intelligence gathering:

#### **Worries**

What are your worries about the child, please include attendance, presentation, behaviour, parental engagement with the school and between parent and child if known? Have there been any specific incidents which occurred outside of school that have impacted on the young person's school life? If yes, please describe them.

#### **Strengths and Safety**

What is going well in school and what is going well in relation to the family? Please include in this section examples of positive support that has been provided to the young person and any positive relationships you have identified in school or with the families.

### **Safety Planning**

If you have any thoughts on any actions that could be put in place to support the young person please advise us of them.

### **Positions of Trust Law**

The Ministry of Justice (MoJ) has announced the Positions of Trust law, which currently applies in England and Wales to roles like teachers and social workers, will be extended as part of the Police, Crime, Sentencing and Courts Bill to protect teenagers from abuse by making it illegal for sports coaches and religious leaders to engage in sexual activity with 16 and 17-year-olds in their care. The new legislation



follows the long standing 'Close the Loophole' campaign by the NSPCC. Separately, the Home Office has published a series of factsheets giving details of the measures contained in the Police, Crime, Sentencing and Courts Bill 2021 including a factsheet on the extension of the positions of trust provisions to include individuals who lead activities in sporting and religious settings. In Northern Ireland the Justice Minister has announced plans to widen the current abuse of trust legislation to strengthen the law protecting vulnerable children through an amendment to the Justice (Miscellaneous) Provisions Bill later in 2021.

# **Emergency Duty Team (EDT)**

As of Monday 3rd May, EDT have changed the way they work, this will provide a higher staffing level at the beginning of their shift, with 2 social workers now available from 16:30. EDT will no longer work nightshift and instead have moved to standby which ensures greater capacity to cover the 24/7 365 days per year cover we are legally required to fulfil. There will be no changes to the function of EDT, they will still only take referrals for urgent/crisis work that cannot be safely managed till the next working day. All requests for support from EDT must be made via telephone in the first instance to ensure staff have an understanding of what it is you are requesting. We will not accept email referrals only. Staff will be on call from midnight only to facilitate: CP work, adult safeguarding and Mental Health Act Assessments, all other queries outside of our statutory remit will be passed to daytime colleagues for follow up, this includes anything for 'information sharing' only.

A little bit of background. EDT are a small team of 7 social workers including a team manager, they also have a part time admin officer. The team have responsibility for all statutory functions under the Social Care Act, these include Child Protection, Adult Safeguarding and Mental Health Act Assessments for the county of Northumberland. We are based in Bedlington and cover Northumberland out to Cumbria in the west and Scottish borders in the north. There are 2 staff on shift during the week, we prioritise work that meets our statutory function, wherever possible we will try and support our daytime colleagues, but this will depend on the work that comes via our 'front door' from 5:00pm.
