#### Something's Not Right – For Key Stages 3, 4 and 5

Now that schools are re-opening fully, Northumbria Police would like to remind secondary colleagues of the Home Office campaign which launched in November 2020 – **Something's Not Right** is designed to help secondary school children and young people who have suffered a range of harms, such as sexual and physical abuse during lockdown. In collaboration with the PSHE Association, Barnardo's and the NSPCC, lesson plans have been created for Key Stages 3, 4 and 5. These lessons focus on children's rights to safety, reinforce the campaign's key messages and encourage disclosure of abuse. ### **Barnardo's Education Community launched**

Barnardo's have launched their new <u>Barnardo's Education Community</u> – a resource aimed at teachers, lecturers and staff working in the education sector. Educators will be able to access trauma-informed resources and advice about how to support children and young people with their mental health and wellbeing, including coping with loss, grief and bereavement. It will also provide a *Community of Practice* where education professionals can share and discuss best practice nationwide.



# **DSL Locality Briefings**



The next DSL locality briefings will be taking place in March and the focus of these briefings will be **exploitation**. There will be two briefings for primary colleagues to choose from and a separate briefing for secondary DSLs to enable us to tailor the exploitation briefings appropriately to your phase. Andrew Elliott, Specialist Youth Support Lead will be giving presentations at the event around **Children Going Missing**, this will include:

- Why young people go missing
- The missing process and how the Local Authority responds
- How schools can support the process

We will also be joined at the secondary briefing by Sorted Team Manager Darran Hope who will be discussing the increased exploitation risks to children and young people who are misusing substances. Leigh Graham, Child Exploitation Practitioner for Children's Services will also be attending the secondary briefing to discuss the indicators and impact of exploitation for children and young people.
