All schools/academies/alternative providers need to know about safeguarding is ON ONE PAGE of the NCC website entitled <u>Information for Schools</u> and the <u>Safeguarding and Schools section</u> of the Virtual School webpage.

The minimum safeguarding requirements you should to have in place by law can be found in the DfE's statutory guidance <u>Keeping Children Safe in Education</u> September 2016.

Please remember that it is your responsibility to ensure that safeguarding practice in your own organisation meets required standards and is compliant.

## Keeping Children Safe in Education (KCSiE)

You will already be aware that KCSiE was updated for September 2016 to reflect current priorities from the DfE and OFSTED and to ensure that schools have clear guidance in all areas relating to safeguarding and child protection. The NSPCC have produced a useful checklist of the changes in KCSiE, which you can find by following this link: <u>NSPCC Keeping Children Safe in Education summary</u>

As in previous years the governing body is given the duty of ensuring that all school staff have read Part A of KCSiE and it is important that a record is kept to show that they have read and understood this document.

Within the guidance there are recommendations in relation to your school's policy. Each school should develop their own policy, ensuring it is current, reviewed annually and preferably published on the school website. To support schools the LSCB with the Education and Skills Service are providing a framework which can be used to update your own policy and a checklist to indicate what needs to be included.

## **Single Central Record**

Please be aware of the legal requirement to have an up to date single central record which meets the requirements outlined in the Ofsted Framework (*Inspecting safeguarding in early years, education and skills settings*) and in the statutory guidance Keeping Children Safe in Education. The local authority's primary concern is to ensure that all steps are taken to ensure that pupils are safe, but there is also a significant risk to schools that safeguarding may be judged inadequate during Ofsted inspection if Single Central Record is not completed correctly.

### **Sexting in Schools and Colleges**

Recently produced guidance <u>Sexting in Schools and Colleges</u> is for designated safeguarding leads (DSLs), their deputies, headteachers and senior leadership teams in schools and educational establishments in England. The advice covers:



- Responding to disclosures
- Handling devices and imagery
- Risk assessing situations
- Involving other agencies, including escalation to the police and children's social care
- Recording incidents
- Involving parents
- Preventative education

## **Vulnerability Factors**

The attached paper on Vulnerability Factors is for all professionals to consider the risks associated with sexual exploitation across your organisation in relation to working with children, young people and vulnerable adults. The risk factors have been identified from knowledge of working in this area, information gathered at a number of multi-agency Complex Abuse Strategy Meetings and through the multi-agency Risk Management Group. These meetings have given increased knowledge and understanding of the nature and profile of sexual exploitation in Northumberland. covering rural and urban areas including Beadnell, Alnwick, Amble, Ashington, Bedlington, Cramlington and Blyth.



## **Children Missing from Education**

A child going missing from education is a potential indicator of abuse and neglect, including sexual abuse and sexual exploitation. The DfE's guidance on Children Missing Education was updated in September, available to download here by following this link: <u>Children Missing from Education</u>.

**Internet Safety** 

KCSiE strengthens the advice to schools about internet safety in relation to filtering and monitoring which does not over-block effective teaching and ensuring children are taught about e-safety. One area of e-safety schools can promote is ensuring that parents are fully aware of the risks and can keep their children safe. A useful site is <u>www.net-aware.org.uk</u>

Northumbria Police have also provided advice for schools, including the following:

 The Childnet Digital Leaders Programme has been extended to include Primary and is now open to all UK schools. Schools are invited to register now to join this innovative peer-to-peer education programme. The <u>Childnet Digital Leaders Programme</u> aims to empower children and young people to champion digital citizenship and digital creativity within their schools and to educate their peers, parents and teachers about staying safe online. The programme is delivered by Childnet as part of its work as one of the three charities in the UK Safer Internet Centre.

Since the programme started in secondary schools last year over a thousand young people have undertaken their training to be effective e-safety educators. They have then gone on to deliver activities in their schools to educate their peers about online safety. The Childnet Digital Leaders Programme offers young people access to an exciting online community. Here they access training and support from Childnet's expert team, record achievements, earn badges, and collaborate and share inspiration with schools across the UK. The launch of the programme for primary schools comes with the development of a new tailored platform, separate to that of the secondary schools, which was piloted in 13 primary schools across the UK.

- <u>Parentzone</u> provide a free online course for parents and carers called **Resilient Families** a free online course to help them get to grips with the things you really worry about when the children and young people in your care go online. It includes topics such as radicalisation and extremism, cyberbullying and sexting. It is presented as three short episodes that cover:
  - A child's online world.
  - The Bad Stuff including online extremism and how radicalisation happens.
  - How to use offline parenting skills to help your child stay safe online.
