## Marriage and Civil Partnership Act



The Marriage and Civil Partnership (Minimum Age) Act 2022 comes into force on Monday 27 February 2023. Under existing law, people can enter a marriage or civil partnership at age 18, or 16 to 17 with parental or judicial consent. The Act raises the minimum marriage and civil partnership age to 18, removing all consent requirements.

The Act extends existing forced marriage legislation, so it will be an offence to carry out any conduct causing a child to marry before their eighteenth birthday, even if violence, threats or another form of coercion aren't used.

Marriage and forced marriage are taught as part of the RSHE curriculum. Please ensure your teaching now covers these points.

**Toolkits to Address Misogyny and Gender-based Violence in Secondary** 

#### **Schools**



Over Christmas the profile and misogynistic actions of Andrew Tate were in the news again. It is probably that young people will want to discuss and better understand concepts of misogyny, sexual violence and safe and respectful relationships, as the media coverage of events does not always answer the questions young people have. Two toolkits from the organisation Bold Voices have been recently developed and both

are available to download free from their website

What is a culture of gender-based violence? Is a guide to help staff to understand the language, concepts and legal definitions they need when they are preparing and empowering young people to understand cultures of gender-based violence.

How to talk to young people about Andrew Tate is a toolkit devised to help educators who want to set up a friendly but challenging space to facilitate conversations about masculinity role models, the continuum of gender-based violence, objectification and status. The lesson ideas contained in the resource are recommended for Years 10 and 11. For further information and advice, go to the Bold Voices website.

#### Northumberland ICT Team

The Northumberland ICT team provide a range of online safety support, guidance and training opportunities via ICT SLA3 - Online Safety. Full details and dates for training sessions can be found in <a href="mailto:this guide">this guide</a>.

The team have recently taken a new approach and have moved away from delivering annual

parent sessions for several reasons but primarily, because in almost all cases, schools really struggled to get many parents to attend and engage with the session. But more importantly, because evidence now points towards a 'drip-fed' approach being the most effective. For example, sending out bite-sized tips and links on a regular basis and adding an online safety 5-minute section to your coffee mornings and class assemblies. Ideally, these sessions are delivered by a member of your team as they have the relationship with your families and wider community to know what information is needed and can exploit those small windows of opportunity throughout the year to reach as many parents as possible. The Northumberland ICT team will support you to ensure you have the knowledge-base and access to the right resources to feel comfortable doing this.

## **Coming Soon!**

The team are developing a package that will include:

Access to an online safety website hosting key information and resources as well as a new online safety self-review tool.

A parent newsletter which you can ask parents to subscribe to directly - or you can subscribe as a school and forward on the relevant aspects as part of your own newsletter.

A range of short videos which can be used as part of the 'drip-fed' approach mentioned above, covering topics like filtering, how to speak to your child about their lives online and online challenges and slides that can be adapted to help you talk to parents about your approach to Online Safety in your school.
