Early Years Pupil Premium Extra funding for your Early Years provider to further enhance the early years provision for your child!









What is Early Years Pupil Premium?

Early Years Pupil Premium is extra funding that can be claimed for eligible 3 and 4 year old children who are accessing a free early education and childcare place to support their learning, care and development.

How much will Early Years providers receive? We can claim up to £300 per year for each eligible child.

How will Early Years providers use this funding?

We will use this extra funding to enhance the quality of your child's early years experience, for example to improve teaching and learning, facilities, resources and training. All of which will have a positive impact on your child's progress and development.

Why is it important to support my Early Years Provider to claim this funding?

High quality early years education and childcare can influence how well a child achieves at both primary and secondary school so we want to make the most of this additional funding.

We therefore ask that if you believe your child is eligible, please fill in the form on the back of this leaflet.





Is my child eligible for the Early Years Pupil Premium?

Your child may be eligible for the EYPP if you receive any of these benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment & Support Allowance
- Universal Credit
- Support from NASS (National Asylum Support Service) under part 6 of the Immigration and Asylum Act 1999
- The guarantee element of State Pension Credit
- Child Tax Credit (provided that you are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190*)
- Working Tax Credit run-on

Early Years providers may also be able to get extra funding if your child:

- Has been looked after by the local authority for at least one day
- Has been adopted from care

Has left care through a special guardianship order

 Is subject to a child arrangement order
