# DfE Guidance - Keeping Children Safe in Education 2022



The DfE has published the updated version of Keeping Children Safe in Education (KCSiE). Although this guidance is available to download, it is not to be put into practice until September 2022. # Management change for the EOTAS Health Needs Service

# **FGM Reporting Procedures**

FGM is an illegal and life-threatening form of abuse which is often performed without anaesthetic and can leave its victims in agony and with physical and psychological problems. Over 200 million girls and women around the world have suffered some form of FGM. School holidays are a particular time of risk for a girl to be taken abroad for the purpose of FGM. Staff in schools may have cause for concern where:

- A girl is going abroad but seems vague about where they are going and how long for, is reluctant to talk about the holiday, or seems upset or scared when discussing it but won't say why.
- Parents ask to take their daughter out of school before the holidays begin and/or are uncommunicative or become aggressive when asked about their plans.

## Signs a girl may have had FGM

Signs that indicate a child may have been a victim of FGM include where she:

- Is absent for a long time from school.
- Goes to the toilet more than usual or stays in there for an unusually long time.
- Isn't able to cross her legs when sitting down on the floor.
- Is reluctant to do PE.
- Suffers urinary tract infections.
- Shows signs of pain or clutches her body.
- Is absent from school when she has her period.

## **Female Genital Mutilation reporting procedures**

Where there is a disclosure of FGM it is important that staff know what their statutory response should be. Keeping Children Safe in Education (2021), paragraph 40 says 'whilst \*\*all\*\* staff should speak to the designated safeguarding lead (or deputy) with regard to any concerns about female genital mutilation (FGM), there is a specific \*\*legal duty on teachers\*\*. If a teacher, in the course of their work in the profession, discovers that an act of FGM appears to have been carried out on a girl under the age of 18, the teacher must report this to the police'.

What is often less well-know is what a teacher should do next to make a report.

Below is a very short summary and must be read in conjunction with the mandatory reporting guidance, available by following this <u>link</u>

# The mandatory reporting procedures say:

'It is recommended that you make a report orally by calling 101, the single non-emergency number.'

'Where there is a risk to life or likelihood of serious immediate harm, professionals should report the case immediately to police, including dialling 999 if appropriate'.

In most cases 'reports under the duty should be made as soon as possible after a case is discovered, and best practice is for reports to be made by the close of the next working day'.

The procedures also set out what information is needed, in order to make a report.

## **Hidden Men**



Safeguarding practice reviews (formerly known as serious case reviews) often find that the role men play in children's home lives is not always clearly understood by professionals working with families, including schools. Sometimes the person being referred to as 'dad' may not even be the same man throughout the safeguarding notes and records. It is important that we understand the impact of these 'hidden men'.

# **Getting it Right for Children**



The following information was provided by Helen Lancaster, Senior Project and Development Manager Early Intervention and Prevention: We are currently planning to run 2 more virtual Getting it Right for Children groups as part of the pilot, the proposed dates are shown below. It is also hoped there will be a trial face to face group as well. The parents who are currently attending this group have expressed they are finding this group very helpful and thought provoking.

This is for separating or separated parents who are experiencing conflict which might be harmful to their children. (For example, where contact arrangements are not consistent, communication is difficult, children are aware their parents are arguing or where children are involved in passing messages between parents).

Two groups will run concurrently to allow each partner to attend separately (both parents do not necessarily need to attend but this is strongly encouraged).

**Group 1: Starts on Wednesday 22<sup>nd</sup> June** (then 29th, 6<sup>th</sup> July and a follow up session on 20<sup>th</sup> July) at 8.00-9.00pm

**Group 2: Starting on Monday 18<sup>th</sup> July** (then 25th July 1<sup>st</sup> August and a follow up on 15<sup>th</sup> August) 10.00-11.00am.

This intervention does not work with parents who have been in an abusive relationship. The programme is for parents where there is not an imbalance of power, neither parent is fearful of the other and there are no specialist domestic abuse services working with the family. You should be clear before you refer that you have explored this, and you are satisfied domestic abuse is not or has not been present in this relationship. If you have a family you wish to refer, please discuss this with them before doing so. Nominations to the suitable sessions for parents (below) can be made by completing the <a href="Request for Service">Request for Service</a> form, or you can contact the facilitators delivering the programmes.

# **Healthy Relationships Resource Pack (Safelives)**



In 2019, SafeLives gathered the voices and perspectives of men and boys aged 11 and over, asking them about abuse, masculinity and what a 'healthy' relationship looks like. Almost a third of respondents said they had demonstrated behaviour within a relationship that they regretted. Professionals working with young people are in the unique position to support them to have healthy relationships during this critical window - before they harm or are harmed.

To do this, professionals need to feel confident starting conversations about relationships. Building on the research, SafeLives have developed a resource pack that practitioners could use to start conversations with young people about relationships and explore what healthy looks like.

# **Contact Information**

Please could you make sure that the Schools Safeguarding Team has up to date contact information for the DSLs in your setting. This is particularly important for our colleagues in Operation Encompass as 'undeliverable emails' mean that children and young people are not getting the support they need following domestic abuse incidents in their homes.





If a DSL in your setting has left, is on leave or has changed their name/email address, please let us know as soon as possible. That way, we can ensure the correct information is getting to the correct people without any delays.

# **Notifying Parents/Carers**

All schools in Northumberland are Operation Encompass and Operation Endeavour schools and you must notify parents of this. The end of this term and beginning of the new academic year are both good times to remind parent of this and it's especially important that new parents/carers are notified. The template letters have recently been updated and are available for you to cut and paste from the **DSL in Schools and APs SharePoint** site, in the Operation Encompass folder. You can also add the letters and logos to your school website.



There is an up-to-date list of DASV support services available in the DASV folder on the DSL in Schools and APs SharePoint site, please share this information with parents and carers via your website, newsletters and through signage in schools. DASV incidents rise during school holidays so it's helpful for families to have this information before you break up for summer.

## **Additional Reminder**

If your school receives an Operation Encompass or Operation Endeavour notification for a pupil attending **EOTAS** or an Alternative Provider, it is your responsibility to pass on that notification to the child's setting.
