# Changes to Children's social care and Early Help family work services

From 1<sup>st</sup> April 2017 changes were made to the ways in which children's social care and early help family support is provided to families across Northumberland. The aim of the change is to provide more joined up early help support at a local level for families with complex needs who don't meet the threshold for statutory social work intervention. The main changes are as follows:

- 1. Creation of four Early Help Family Work locality teams
- 2. Creation of four Northumberland County Council Early Help Locality Managers
- 3. Changes to the Early Help Coordinators and Hub administration

All schools/academies/alternative providers need to know about safeguarding is ON ONE PAGE of the NCC website entitled <u>Information for Schools</u> and the <u>Safeguarding and Schools section</u> of the Virtual School webpage.

The minimum safeguarding requirements you should to have in place by law can be found in the DfE's statutory guidance <u>Keeping Children Safe in Education</u> September 2016.

Make sure you and your staff have access to the most up to date version. The initial draft which was published in July 2016 was refreshed and schools must use the September 2016.

Please remember that it is your responsibility to ensure that safeguarding practice in your own organisation meets required standards and is compliant.

## Child sexual exploitation (CSE) update

The government have revised the **statutory definition of child sexual exploitation** along with new working together advice on CSE. The revised definition is:

Child sexual exploitation is a form of child sexual abuse. It occurs where an individual or group takes advantage of an imbalance of power to coerce, manipulate or deceive a child or young person under the age of 18 into sexual activity (a) in exchange for something the victim needs or wants, and/or (b) for the financial advantage or increased status of the perpetrator or facilitator. The victim may have been sexually exploited even if the sexual activity appears consensual. Child sexual exploitation does not always involve physical contact; it can also occur through the use of technology.

#### **Domestic Homicide Review**

NCC has recently been involved in a multi-agency Domestic Homicide Review (DHR) following the killing of a mother by her 16 year old son in 2015. The DHR is now complete and there will be a multi agency group established to look at the action plan. All professionals need to be aware of the Home Office Guidance '*Adolescent to Parent Violence and Abuse*' (APVA), which can be found here:

Schools must ensure they pay particular attention to coercive control within family dynamic, ensure that the child/young person and the adult are being safeguarded and supported and any concerns regarding Adolescent to Parent Violence and Abuse should be discussed with children's social care (01670 536000) or adult services (01670 536400).

## **Operation Encompass**

Operation Encompass went live in Northumberland on 3rd April and the majority of schools have met the required criteria to ensure they receive a child concern notification when children and young people (aged 4 - 16 years) who attend their school have been at home when the police have been called out to a domestic violence incident.

To receive the notifications the Headteacher or DSL must have attended a briefing, staff must be trained and parents must have been notified (using a template letter provided by the LA) that the school is part of this initiative. **There is an expectation that all schools will participate in this initiative.**


# Safeguarding: Service Level Agreement 2017-18
