Updated Threshold Document

The new Threshold Document has now been endorsed by the full Safeguarding partnership and is available on the DSL in Schools and APs SharePoint site. It would be helpful if you could read the new guidance before the briefings and come prepared to ask questions.

North and South of Tyne Safeguarding Children Partnership procedures manual

The North and South of Tyne Safeguarding Children Partnership procedures manual has recently been updated, here is a summary of the amendments:

Allegations Against Staff or Volunteers who Work with Children

This chapter has been updated to reflect Keeping Children Safe in Education regarding allegations that can relate to an adult's behaviour outside work known as transferable risk, and in relation to the importance of sharing any concerns about the behaviour of a person who works with children. Information has been added on the differences between an allegation and a concern.

Information Sharing

Good Practice supporting the Voice of the Child

Bruising in Pre/Non-Mobile Children (local information)

Pathway of Care Regarding a Birth Mark including Congenital Dermal Melano cytosis (Mongolian Blue Spots MBS) or Suspected Medically Induced Injury (following birth etc) (NHS North East and North Cumbria) has been added.

Child to Parent Violence and Abuse

International Day of Disabled Persons



Information provided by Ian Walker, Senior Manager for Disabled Children, on behalf of the Safeguarding Disabled Children Subgroup. International Day of Disabled Persons is held each year on 3rd December. The theme this year is **Not all disabilities are visible.**

Some disabilities, like mental health disorders, chronic pain and fatigue, are invisible but that does not make them any less devastating to someone's quality of life. Nor does it mean we shouldn't try to support people who are dealing with these invisible disabilities, in fact it probably means we need to try harder in our day-to-day work and practice to recognise issues people may be having and support in any way that we can.

To celebrate this year's International Day of Disabled Persons we are asking all education settings to do something leading up to 3rd December to not only recognise the day but to make a positive pledge on how they will make a meaningful change in your ways of working to improve things for people dealing with an invisible illness.

The ask is as follows:

- 1. Ask each setting to undertake an event week commencing 28th November 2022 to look at this this doesn't have to be grand, a discussion slot in a team meeting, a lunchtime discussion etc is fine it just needs to be a dedicated time that you can talk with colleagues about the theme, practice in this area, and one pledge that they would like to make.
- 2. Ensure that you do this yourself to think about your own practice in this area and a pledge that you would like to make.
- 3. By the end of that week we ask each setting to email Ian with brief details of what you did and the pledge you would like to make. Also, email me your own pledges if done individually.
- 4. These pledges will then be collated and distributed we will then ask people to review these over the coming year to see if they are delivering on their pledge.

Prevent – The Prevent duty: Safeguarding Learners Vulnerable to Radicalisation (DfE)

The DFE has produced updated guidance that reflects learning since the implementation of the prevent Duty in 2015, under section 26 of the Counter Terrorism and Security Act 2015. The guidance is to support DSLs and explains the Prevent referral process and the statutory responsibilities to keep children and young people safe from the risk of extremist ideology and radicalisation. It prepares DSLs to respond effectively and to get support for children and young people who may be vulnerable to radicalisation.

Acorns Domestic Abuse Service for Children Aged 4–18



Update on Acorns Service:

Acorns provide therapeutic support for children aged 4-18 years who have been impacted by domestic abuse, but who are now safe. The service can offer counselling and play therapy, usually a 50-minute session at the same time each week for a period of 8-10 weeks. This support can take place in school, or the children and young people can be seen at an external venue.

The support Acorns is able to offer can make an enormous difference and they have had fantastic feedback from schools, parents/carers, children and young people.

Until recently, Acorns had an extremely long waiting list, but the team are working hard to reduce this and the current wait time is around 4 months. The teamwork in clusters in different areas, so this may be a shorter waiting period depending on the number of referrals in your area. For a referral pack, please email admin@acornsproject.org.uk.
